**NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SECOND PHASE COUNSELLING**

In continuation to this office notification dated: 09-11-2024, 03-01-2025, 04-01-2025 and 18-01-2025, KNRUHS hereby notifies the conduct of second phase of web-based counseling for allotment of the vacant Post Graduate seats under Management Quota MQ1 and NRI quota for admission into PG Medical Degree/Diploma courses for the academic year 2024-25 in Private Unaided Non-Minority and Minority Medical colleges in Telangana State affiliated to KNRUHS.

The candidates whose online uploaded certificates were provisionally verified and whose names are notified in the updated provisional final merit list for PG Medical Admissions on the website of KNRUHS, Warangal on 18-01-2025 are eligible to exercise web-options online from computer with internet connection.

The Candidates who were allotted seats in the first phase of counseling and have not reported/discontinued the course at the respective college are not eligible for exercising options.

Candidates who have not exercised web options in the first phase of counseling are also not eligible to exercise web options in accordance with the Government orders.

The candidates who were allotted PG seats in the first phase of counseling and joined the course are eligible to exercise web options and are informed to exercise web options.

All the eligible candidates whose names are displayed in the Provisional final merit list for PG Medical Degree/ Diploma admissions can exercise from **08.00 AM on 19-01-2025 to 6.00 PM on 20-01-2025**

Candidates shall exercise web options for the vacant Post Graduate Medical seats as per their registration and eligibility for MQ-1, MQ-2 (NRI) categories, in order of their priority through <https://pvttspgmed.tsche.in> . Allotment of seats will be done accordingly.

**NOTE:** Candidates are informed that they will be considered only to the category / categories to which they have registered.

For eligibility criteria and regulations refer to notifications dated: 09-11-2024.

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of by way of payment gate-way online and download the allotment letter. Candidates who have already paid University fee in the first phase need not pay again.

MQ 1 Management Quota sub category 1: Rs.49,600/-

MQ2 (NRI) & MQ3 ( Institutional Quota) : Rs.69,600/-

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges. The Tuition fee payable shall be as notified by Government of Telangana orders.

**NOTE:**

The details of vacant seats available (seat matrix) in all Medical Colleges affiliated to KNRUHS are placed in the website <http://knruhs.telangana.gov.in> The candidates can exercise web options for PG Medical Degree/Diploma seats under KNRUHS through <https://pvttspgmed.tsche.in> .

**INSTRUCTIONS TO CANDIDATES:**

- 1) Eligible NEET-PG-2024 qualified Candidates as per provisional final merit list for Management Quota can exercise web options for vacant PG seats in all Medical colleges as per their interest and priority for MQ1 and NRI categories (as per eligibility).
- 2) Candidates are advised to go through the Prospectus for the Regulations for PG courses of KNRUHS, available on website before exercising web options.
- 3) Candidates exercising web options for PG seats are informed that, there is no limit of choices (number) for exercising web-options, candidates can exercise options for any number of subjects and colleges the candidate is interested to join as per eligibility and registration. If they are not interested to join in any subject or college then they should not exercise options for the same.
- 4) Management Quota MQ-1 & MQ-2 (NRI) seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges.
- 5) Candidates have to exercise options for MQ1 and if eligible for MQ2 (NRI) in order of their priority for course and college. Allotments will be made according to the order

of preference in the web options exercised by the candidate. Candidates have to exercise options very carefully as per their priority.

- 6) Candidates are informed that if they exercise web-options for a seat and allotted a seat as per their choice in the web- counseling and if they do not join the course at the allotted college then they will not be eligible for exercising web-options for subsequent round of counseling.
- 7) Candidates can exercise options on the web either from home / any other place having internet facility.
- 8) Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counseling. If candidates are not interested to join in any subject or college they should not exercise web options for the same.
- 9) If a PG seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in 1st phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, the candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 10) Candidates can exercise web options through a computer either from home / any other place having internet facility. Don't use mobiles and Tabs for exercising web options.
- 11) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options).
- 12) Candidates are instructed to take a print out of saved options. Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on portal/website <https://pvttspgmed.tsche.in>
- 13) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking), check their allotment and report to the Principal of allotted college on or before the date specified on the allotment letter.
- 14) Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional

allotment will be cancelled and action may be initiated as per University Regulations.

- 15) Selected candidates have to report at the respective colleges before the last date for joining as specified in the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee / college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within the specified date the admission will be cancelled automatically and the candidate will not be permitted to exercise web options for subsequent round.
- 16) If the candidate slides to other college during second phase of counseling, they have to get relieved from first phase joined college, collect original certificates, fees and report to the allotted college before last date of joining.
- 17) Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
- 18) Original certificates will not be returned to the candidate, unless the candidate discontinues the course or slides to other college during subsequent phase of counseling.
- 19) Allotment for Institutional quota will be done after all the relevant sponsorship letters for institutional quota are received by the University from the Medical Colleges.
- 20) The University fee once paid shall not be refunded under any circumstances.
